The meeting was called to order by Michelle Moren-Grey at 9:03 a.m.

Committee Members: Ms. Moren-Grey reported that there were two new communities to the committee: Sharon Gellor/Town of Carroll; Peter Corey/Town of Whitefield; Julia Gilmore and Joe Marshall/Town of Jefferson; Norman Cloutier/Town of Columbia; Gregor Stock. The new communities on board Town of Dalton and John White/Town of Clarksville. Thirteen communities have joined from the initial outreach. There are seven communities that have not responded and she will reach out to them. Carol Miller stated that she would reach out to the Town of Gorham and offer to be that town's representative. Michelle reported that two new member sessions were held prior to the meeting to bring everyone up to date.

Michelle provided updates on the USDA Rural Development Business Grant which is a feasibility study and a CDBG grants. A letter of intent was submitted by Coös County to the USDA RDBG and the application is due at the end of February. The City of Berlin also submitted a letter of intent. The ask was \$30,000 from each. Both Coös County and the City of Berlin will be applying for CDBG in the amount of \$25,000 each.

Pam Laflamme reported that she had spoken with a representative at USDA and this is a good round to be applying for funds. Both, Michelle and Pam will strategize to determine resources needed. Also, the grant application can be done at any time but both entities should submit at the same time. The funds cannot be co-mingled.

Carol Miller provided and overview of closing the homework gap. First she reported that FCC funded awards in December to be spent in New Hampshire over 10 years.

Consolidated Communications was awarded \$7.3 million to bring connectivity or broadband to 4,644 locations statewide. She was not sure what is allocated for Coös County but will provide the information once the funds are released.

Spectrum in Coös County was awarded \$2.1 million for 1,044 locations in this area.

New Hampshire Electric Cooperative was awarded \$6.8 million for territories in Coös, Grafton and Carroll counties

Space Exploration Technology was awarded \$8.8 million for 4,389 locations statewide.

Northern Border Regional Commission announced forest economy awards. Vermont Department of Public Service was awarded \$1 million to expand broadband across the state of Vermont. She will obtain further information.

The Northern Forest Center was awarded \$1 million. This group is also are restoring the Noyes Building in Lancaster and received \$189,000 for broadband work.

Carol is working with a group from UNH on a civics project that involves six towns in NH which include Groveton, Gorham and maybe Whitefield. The group is concerned on homework gap and issues with students who have remote learning and have difficulties with internet access. The project would consist of 30 homes in a grid area which would be difficult in northern New Hampshire. The grant funds would only be available to the towns that are part of the project.

Carol is also researching a company called Kajeet. Kajeet uses cellular to create hotspots for connectivity. This interim system is available with cell service. Good interim project during covid19.

## **Guest Presentations:**

Michelle this will be an opportunity for the group to bring in guests. She suggested holding guest presentations at every other meeting. She and Carol shared some of the ideas that they brainstormed:

- homework gap
- funding structures and opportunities
- collaborative on digital inequity
- legislation and funding
- broadband study committee

Wayne asked that the house bill numbers be circulated. Those interest could follow and communicate on the house bills.

Peter Corey offered to update the committee on NCIC. Carol thought it was a great idea.

Wayne asked for more information on Starlink. Carol will research to see who would be available for a presentation.

Carol inquired from Sharon Penney for an update relating to NH Electric Coop. Sharon replied that the town had received a request for a letter of support which the Town of Colebrook provided. She has not received any information since.

Michelle asked that members check with their community to be sure that their request for information (RFI) and E911 requests be completed. Also asked that members who are representing a town be officially appointed by their Selectboards if they have not done so.

The minutes will be posted on the Coös County website and Linda will distribute to all members.

The next meeting is scheduled for February 24, 2021.

Michelle asked that the members report back to their Selectboards.

The meeting was adjourned at 10:01 a.m. by roll call.
