Part II of the meeting will be an informational presentation organized in response to the Delegation's expression of interest, at the meeting in July, on the subject of the Coös forest lands, their management. The Coös forest lands have been the subject of a recent U.S. Second Congressional District meeting and a Dartmouth College gathering focused on the Second College Grant UP. Both meetings focused on the future of the Northern Forest in a time of climate change. Due to time limitations, a review of the NH system of Yield (Timber) Taxes and UP revenue, will be scheduled for a separate meeting.
